# **Program**

To participate in the Agricultural Water Use Exclusion Program (AWUEP) as administered by Olivenhain Municipal Water District (OMWD), and qualify for a voluntary 15% reduction in water use rather than the mandated 32% reduction called for by the State of California, the applicant shall be required to provide the documentation, certification and acknowledgement as indicated on this form for each meter/account number for which the customer is interested.

## **Definitions**

- **Agricultural use** is defined as use of land, including but not limited to greenhouses, for the purpose of producing an agricultural commodity for commercial purposes. { *Government Code Section §51201*}
- **Commercial purposes** is defined as a minimum of \$1,000 in annual sales.

## Section 1 – QUALIFICATIONS FOR PROGRAM

To qualify for the above stated program, potable water served to this property is used for the purpose of producing an agricultural commodity for commercial purposes. The water used on this property shall be limited to parcels of land irrigated for the growing of agricultural, horticultural or floricultural product(s), produced for human consumption or for the market, or (2) for the feeding of fowl or livestock produced for human consumption or for the market, or (3) for the feeding of fowl or livestock for the purpose of obtaining their products for human consumption or for the market. Evidence of an agricultural business must be provided via sales receipts and/or tax returns documenting at least \$1,000 in annual agricultural commodity sales (such as IRS Schedule F).
