MINUTES OF A REGULAR MEETING OF THE BOARD OF DIRECTORS OF THE OLIVENHAIN MUNICIPAL WATER DISTRICT

July 20, 2022

A regular meeting of the Board of Directors of Olivenhain Municipal Water District was held on Wednesday, July 20, 2022, via video conference and in person.

The district's water system complies with all of the health-based drinking water standards and maximum contaminant levels required by the California Department of Health Services and the US EPA.
