A: The electronic PDF of the "Contract Documents" file has been replaced with a more user-friendly format including searchability function. No changes have been made to the electronic file except electronic formatting.

The original "Appendix K" and "Appendix K – Report Appendices" files included bookmarks and searchability function, and no changes have been made.

2. **Q: Due to the complexity of this project we are requesting a 2 week extension of the Bid due date in order to ensure a complete and responsive bid.**
