Note: All Full installations and installation of meters 2" and larger will be charged on a time and materials basis. These charges may vary with the circumstances found in the field, i.e., additional traffic control, longer than average lengths of pipe, rocky soil conditions, etc.

Per the Engineer's Report on Assessment District No. 96-1: Parcels of 1/2 acre or less are required to have a minimum of a 3/4" meter installed. Parcels greater than 1/2 acre, but less than 3 acres require a minimum of a 1" meter installed. Parcels greater than 3 acres require a minimum of 1 1/2" meter. Additional parameters will dictate the appropriate size of the meter, at the sole discretion of the District. Any meter may be upsized upon the payment of the appropriate District and SDCWA capacity fees and installation charges.

Fire Flow Test \$500 flat fee

Fire meter only fees: 3/4" fire meter = \$1,100 installation charge for T&M.
 1" fire meter = \$1,125 installation charge for T&M.

CWA equivalent EDU factors: <1"=1.0, 1"=1.6, 1.5"=3.0, 2"=5.2, 3"=9.6, 4"=16.4, 6"=30.0, 8"=52.0
