### OMWD is Planning an IMPORTANT PROJECT in Your Neighborhood

Our region is reliant on water that is imported from hundreds of miles away. Whether coming from the Sacramento-San Joaquin Delta or the Colorado River, the availability of these distant water sources can vary based on drought and other potential water supply interruptions.

Olivenhain Municipal Water
District is committed to providing
its customers with a secure and
reliable water supply, and using
locally produced recycled water for
irrigation is important in honoring
that commitment. Recycled water is a
safe and sustainable source of supply
that reduces reliance on imported
water. OMWD currently delivers about
850 million gallons of recycled water
annually, offsetting its potable water
demand by around 14 percent.

To expand the availability of OMWD's recycled water, OMWD is planning to connect to San Elijo Joint Powers Authority's recycled water transmission pipeline near Interstate 5 and Via Poco. From that connection, OMWD will construct a new recycled water pipeline along Manchester Avenue in the City of Encinitas.

The Manchester Avenue Recycled Water Pipeline Project involves the construction of approximately 1.4 miles of six-inch diameter recycled water pipeline. The new pipeline will expand recycled water service to the corridor along Manchester Avenue and South El Camino Real from Interstate 5 to Tennis Club Drive.

Homeowner associations, schools, and businesses along the project alignment that are currently using potable water for landscape irrigation will be able to take advantage of this lower-cost, drought-resistant local source of water for irrigation.

The pipeline will deliver recycled water supplied from San Elijo Joint Powers Authority's San Elijo Water Reclamation Facility. The Project is part of the larger North San Diego Water Reuse Coalition's Regional Recycled Water Project, which coordinates resources across the jurisdictional lines of nine North County agencies.

This project has been awarded \$600,000 in Proposition 84 grant funding for a portion of the project. An additional \$750,000 in grant funds from Proposition 1 has been

secured for the remainder of the pipeline. Construction is anticipated to begin in summer 2020 and will take approximately seven months to complete.

# **Environmental Public Comment Period & Public Hearing**

OMWD has prepared an Initial Study/Mitigated Negative Declaration (IS/MND) that addresses the potential environmental impacts of the Project in accordance with the California Environmental Quality Act. The analysis in the Initial Study supports the conclusion that, with the inclusion of mitigation measures, the project would not result in significant environmental impacts.

On November 13, 2019, OMWD's Board of Directors approved the release of the IS/MND document for public review and comment.
