Total Yearly Sewer Bill based on assigned Serviced EDUs per Assessor Parcel plus Total Yearly HCF Usage  Example for C1 (Commercial 1): (Serviced EDUs x \$181.09) + (Total Yearly HCF Usage x \$6.59)	<u>2019-2020 Commodity Charge</u> <u>Per User Group</u> MF (Multi-Family) = \$6.59/HCF C1 (Commercial 1) = \$6.59/HCF C2 (Commercial 2) = \$10.16/HCF C3 (Commercial 3) = \$11.36/HCF
